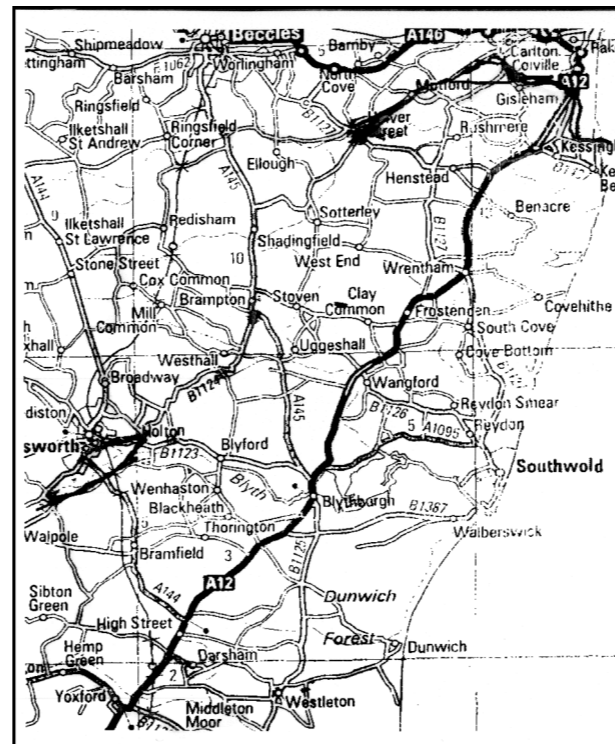

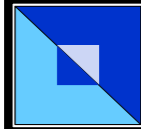

When Community Case Manager Cathy Ryan started caring for the patients of Sole Bay Health Centre she found that there was a desperate need for a fund that would supply a rapid response to meet an urgent medical or social need.

The Sole Bay Care fund provides short term emergency care, resources and equipment not normally funded by the NHS or Social Services.

At times it is necessary to bring immediate care and support to those patients with an acute medical or social care need. In many cases unnecessary hospital admissions can be prevented by providing short term care in the home or as near to home as possible.

The needs are many and varied, from arranging for a key safe to be fitted, emergency respite care for a dependent or 24h nursing care at home.
